

## **IANA Services Activity**

Protocol Parameter requests since IETF 113 (March-June 2022)

Processed more than 791 IETF-related requests.

This includes: document reviews, registry creation, new registrations, modifications to existing registrations, and deletions.

### Update on Deliverables, Projects and Documentation

- Registry workflow system work progressing. Private Enterprise Number (PEN) request-submission/processing component planned for launch in 3rd Quarter 2022.
- The FY24 PTI Operating Plan & Budget is being developed. PTI operating assumptions and priorities are being discussed with oversight groups prior to a public webinar on August 11th.
- Designated experts contact outreach: We began contacting active/inactive experts in July. The purpose of this outreach is to to confirm their email address and availability.

#### IANA Services and DNSSEC

As of 7 July 2022, 1371 TLDs have a full chain of trust from the root.

KSK Ceremony 45 was successfully executed on 12 May 2022. KSK Ceremony 46 is scheduled for 17 August 2022.

Due to current world health concerns, plans continue to be very fluid and may change.
