

## **Processing IETF Related Requests**

A look over the past 12 months (October 2020 - September 2021)\*

## **IANA Services Activity**

Protocol Parameter requests since IETF 111 (July 2021 – September 2021\*)

Processed more than 615 IETF-related requests.

This includes: Document reviews, registry creations, new registrations, modifications to existing registrations, and deletions.

- Reviewed 39 I-Ds in Last Call
- Reviewed 34 in IETF Evaluation
- Reviewed 35 documents becoming RFCs
  (26 of the 35 documents had registry actions of some form)
- Media Type requests: 12
- Ports + Port modification requests: 24
- New Private Enterprise Numbers: 326

5 new registry URLs and 31 new registries were added since IETF 111.

\* 3 month period instead of the usual 4 month period

### **SLA Performance**

Average cumulative percentage for April 2021 through September 2021 was 100%.

### Update on Deliverables, Projects and Documentation

- The draft 2022 Supplemental Agreement is currently under review.
- Registry workflow system work progressing. Development work currently focused on processing First Come First Served requests, starting with Private Enterprise Number (PEN) Requests.
- Nameservers for the Address and Routing Parameter Area ("arpa")
  Domain approved for publication:

  - Implementation of nameserver changes planned for March 2022

#### IANA Services and DNSSEC

As of 21 October 2021, 1370 TLDs have a full chain of trust from the root.
