

## **IANA Services Activity**

Protocol Parameter requests since IETF 114 (July-September 2022)

Processed more than 526 IETF-related requests.

This includes: document reviews, registry creation, new registrations, modifications to existing registrations, and deletions.

### Update on Deliverables, Projects and Documentation

- Registry workflow system work progressing. Private Enterprise Number (PEN) request-submission/processing component planned for launch in November 2022.
- The Public Comment period for the FY24 PTI Operating Plan & Budget has been extended until 17 November 2022.
- Designated experts contact outreach: We began contacting active/inactive experts in July. The purpose of this outreach is to confirm their email address and availability. We're also asking them to suggest additional/replacement experts (if appropriate), soliciting feedback, and providing information about IANA processes.

#### IANA Services and DNSSEC

As of 28 October 2022, 1362 TLDs have a full chain of trust from the root.

KSK Ceremony 46 (KMF West) was successfully executed on 17 August 2022. KSK Ceremony 47 (KMF East) is scheduled for 03 November 2022.

Due to current world health concerns, plans continue to be very fluid and may change.
