Charter Update (Lars)

- All documents have shepherding statements
- NFSv4.1 document will need an 2 month IETF last call
 - Lars to finish AD review next week
 - Start IETF Last Calls the middle of August to October
 - IESG review starts in October
 - Will not be approved before Minneapolis (November)
- The other documents will progress in parallel, should be done before Minneapolis
- New charter should progress existing documents to Draft and Standard
 - Will need to gather interoperability reports
- Future documents should not be large and monolithic
