IETF 113 Vienna go/no-go assessment

This is the assessment of whether IETF 113 Vienna can go ahead as an in-person meeting or whether it will need to be replaced with some form of online meeting. It has been made by the IETF Executive Director assisted by the IETF Secretariat and local contacts. This assessment follows the published framework in RFC 9137¹.

Recommendation

The recommendation is that **an in-person meeting go ahead** noting that this will be under special conditions and that one of the criteria has not been met.

Classification system

This assessment uses the following classification system for each criterion:

The decision to be made is whether we can be confident that the global situation will have improved sufficiently by March for the meeting to go ahead. Because of that approach, each criterion needs to meet a threshold of "met" or "confident it will be met" for it to be indicated as green. If the threshold is not met then it stays as red. There is no intermediate amber to express an uncertain but possible likelihood.

Assessment of individual criteria

Special note

The IESG has determined the following, which impacts on this assessment:

- A level of onsite participation at 50% of a similar pre-COVID meeting is acceptable for a viable meeting. This is in the range of 500-650.
- Any specific regulations that adversely affect unvaccinated people are not to be considered discriminatory.

General background

Austria has some of the strictest rules globally regarding COVID mitigation and the risk posed by unvaccinated people. It has recently come out of a lockdown and has falling infection rates. However the effect of omicron has not yet been felt in Austria and conditions may change.

CRITERION: The IETF LLC is able to hold the meeting.

CRITERION: Economic, safety, and health risks associated with this Venue are acceptable.

#	Test	Assessment	
3.1	Local assessment of the health and safety risk of travelling to the venue.	Austria has implemented the 2G+ rule ⁶ intended to minimise the likelihood of infected people traveling (and thereby infecting other travellers). ASSESSMENT Met	
3.2	Independent assessment of the health and safety risk of travelling to the venue.	The US CDC has a "Level 4: Avoid travel" notice for Austria ⁷ which then leads to the US State Dept having Austria at "Level 4: Do Not Travel" ⁸ . ASSESSMENT: Not confident that it will be met	
3.3	Assessment of the health and safety risk of air travel in and of itself.	The WHO defer to IATA on the matter of the safety of air travel and IATA have produced evidence to support their view that air travel is low risk ⁹ .

CRITERION: Travel to the Venue is acceptable based on cost, time, and burden for participants traveling from multiple regions. It is anticipated that the burden borne will generally be shared over the course of multiple years.

Assessed on a per country basis

Given the difficulty of collecting global data, assessment of the criteria in this section has been carried out in a lightweight manner by utilising flight comparison websites and searching for flights from the capital cities of the top 5 countries by percentage (China, Germany, UK, Canada, Japan based on IETF 112 attendance¹⁴) for travel to Spain in November, as well as by attempting to book travel insurance from a number of origin countries.

Summary

Of the 19 individual tests, all need to be assessed as "Met" or "Confident it will be met" for an in-person meeting to be held. 1 test has been assessed as "Not met".
