- BIRD: uses the new features since 2.0
- FRR (nee Quagga, nee Zebra): minimal compliancy patches available, needs review
- sbabeld: minimally compliant
- Additionally:
 - wireshark: decodes the new features of rfc6126bis
 - tcpdump: patches submitted, not merged yet (somebody ping mcr)
