- May 28, 2012. Cutoff for charter proposals for topics. [Three weeks prior to BoF proposal deadline, two weeks before announcement of topics]
- June 11, 2012. Topics that are to be the focus of IETF-84 are announced. [Ten days before AD BoF approval, 4 weeks before -00 deadline, *one week* after deadline for requesting WG session]
- July 9, 2012. -00 draft deadline.
- July 16, 2012. Draft deadline.
