# Nominees

- Individuals accepted nominations
  - 37 acceptances for 8 IESG positions
  - 17 acceptances for 6 IAB positions
  - 7 acceptances for 2 IAOC positions
- Thanks to everyone who was willing to serve in any of these leadership positions!

# Community Feedback

- The Nomcom received input: in person (IETF 85), over the phone, via email and via our web tool
- In total, the Nomcom received input from roughly 130 members of the community
- We received input from a broad cross-section of the community including:
  - Past and current IESG/IAB members, Working group chairs, Document authors, IETF veterans and IETF newcomers
- Thanks to all who provided input to Nomcom!

# NomCom Status

- The Nomcom process successfully filled:
  - 2 positions on the IAOC  
(including mid-term vacancy created by the resignation of Marshall Eubanks)
  - 7 positions on the IAB  
(including mid-term vacancy created by the resignation of Jari Arrko)
  - 7 positions on the IESG  
(the TSV AD position has not yet been filled)

# TSV Area Director Position

- The Nomcom process has not yet succeeded in filling the TSV Area Director position vacated by Wes Eddy

- I am optimistic that this situation will be resolved soon after IETF 86

# Observations: RFC 5680

- RFC 5680 permits the Nomcom to make available an open list of individuals who have accepted a nomination
- This Nomcom (and the previous one) followed the recommendations of RFC 5680
- The use of RFC 5680 appears to increase both:
  - The volume of community input received by the Nomcom
  - The diversity of individuals from whom the Nomcom receives input

# Observations: RFC 5633

- RFC 5633 permits the IETF Executive Director to put out the call for Nomcom volunteers prior to the appointment of the Nomcom chair
- The (optional) procedure described in RFC 5633 was NOT followed in 2012
- I was appointed on July 3. The Nomcom membership was not determined until Aug 12
- It is bad for the Nomcom membership to be determined after the summer IETF meeting
- I will make sure that the RFC 5633 procedure is used next year
