 - address the 4PE (Connecting IPv4 Islands over IPv6 MPLS Using IPv4 Provider Edge Routers) gap identified in RFC7439. A new SAFI (4PE SAFI) is introduced in MP-BGP to carry the IPv4 routes together with a MPLS label among the 4PE routers
