- Current Hostname Practice Considered Harmful
  - draft-ietf-intarea-hostname-practice published as informational RFC (RFC 8117)
- Privacy considerations for IP broadcast and multicast protocol designers
  - draft-ietf-intarea-broadcast-consider-02 -> WGLC ended on 03/20
- Generic UDP Encapsulation
  - draft-ietf-intarea-gue-01 adopted as WG item (inherited from nvo3)
- IP over Intentionally Partially Partitioned Links (Call for WG Adoption "still issued" + liaison from IEEE)
  - draft-nordmark-intarea-ippl-05
